

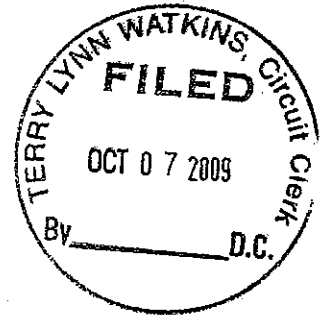

NON-ADJUDICATED SENTENCING ORDER

THIS DAY IN OPEN COURT COMES THE DISTRICT ATTORNEY, WHO PROSECUTES FOR THE STATE OF MISSISSIPPI, THE DEFENDANT, DONNY WILSON, IN HIS OWN AND PROPER PERSON, AND BEING REPRESENTED BY COUNSEL, SAID DEFENDANT HAVING HERETOFORE WAIVED ARRAIGNMENT UPON AND INDICTMENT LAWFULLY RETURNED BY THE GRAND JURY OF LINCOLN COUNTY CHARGING SAID DEFENDANT WITH THE CRIME OF TAX EVASION (FOUR COUNTS) AND BEING DULY ADVISED OF THE CONSEQUENCES OF SUCH A PLEA, THE DEFENDANT DID THEN AND THERE ENTER HIS PLEA OF GUILTY TO A CHARGE OF TAX EVASION (FOUR COUNTS). ALL COUNTS TO RUN CONSECUTIVELY.

THEREFORE, FOR SAID OFFENSE AND ON SAID PLEA OF GUILTY, THE COURT SPECIFICALLY WITHHOLDS ACCEPTANCE OF DEFENDANT'S PLEA AND ADJUDICATION OF GUILT AND IMPOSITION OF SENTENCE IN ACCORDANCE WITH SECTION 99-15-26 MISSISSIPPI CODE OF 1972, AS AMENDED, PENDING SUCCESSFUL COMPLETION OF THE CONDITIONS IMPOSED IN THIS ORDER.

IT IS THEREFORE ORDERED THAT THE DEFENDANT BE PLACED ON NON-ADJUDICATED PROBATION UNDER THE SUPERVISION OF THE MISSISSIPPI DEPARTMENT OF CORRECTIONS FOR A PERIOD OF FIVE (5) YEARS. THE DEFENDANT SHALL ~~BE~~ SUBMIT ANNUAL FINANCIAL STATEMENTS TO THE COURT AND PRESENT HIMSELF ANNUALLY FOR REVIEW OF HIS ABILITY TO REPAY MONIES OWED. THE FIRST REVIEW IS
